RULES & REGULATIONS

- 1 SYSTEM OF PLAY :** The Latest FIDE Rules in force shall apply and the Swiss System will be followed.
- 2 ROUNDS :** A total of 9 rounds will be played.
- 3 TIME CONTROL :** 10 minutes per player + 5 seconds increment per move from move 1.
- 4 DEFAULT TIME :** 10 Minutes.
- 5 TIE BREAK :** Latest AICF Tie-Break will be applied. In case of a tie, prizes will not be shared.
- 6 AICF REGISTRATION :** Compulsory for Indian players; ₹300 for 2026–2027. Registration is online only and must be completed before the event.

New players need a birth certificate, a unique email address not used by another AICF player, and a passport-size JPEG photograph under 1 MB.
- 7 TNSCA REGISTRATION :** Compulsory for Tamil Nadu players; ₹150 for 2026–2027. Complete registration before the event.

Keep a birth certificate, valid email address and passport-size JPEG photograph under 1 MB ready.
- 8 Pudukkottai District Player Registration :** Pudukkottai DCA player registration fee is Rs.75/- for the year 2026 – 2027 (for Pudukkottai district players only).
- 9 PROTESTS :** Protests if any, against the decision of the Chief Arbiter shall be made in writing with protest fee of Rs.1000/- within 15 minutes of the completion of the game to the appeals committee. The protest fee will be refunded if the appeal is upheld.
- 10 APPEALS COMMITTEE :** Formed from senior participants at the players' meeting before play. Its decisions are final and binding.
- 11 WITHDRAWAL :** Players may withdraw after informing the Chief Arbiter in writing.
- 12 ENTRY DEAD LINE :** 7th October 2026.
- 13 RIGHTS OF ADMISSION :** The AICF / TNSCA / Pudukkottai DCA/organizer Masters Chess Academy reserves the rights of admission to the Venue.
- 14 CHIEF ARBITER :** IA NI SUNDAR R.J.
- 15 WRISTWATCHES :** As per AICF regulations the wrist watches are restricted inside the playing hall in all FIDE Rated events. Players are instructed not to wear any kind of wrist watches while playing.
- 16 FOOD :** Players must make their own arrangements for food.
